Invitation for Bids

1. Kanchanrup Municipality, Office of the Municipal Executive, Kanchanpur, Saptari invites electronic bids from eligible bidders for the procurement of works as mentioned in the table below:
2. Bidding will be conducted through National Competitive Bidding (NCB) procedures (Model Bidding Document as per Electronic Government Procurement issued by PPMO). This is open to all eligible bidders.
3. All bidders are notified that 50% budget of the total cost of the projects under Contract I.D. No. KRM/SPT/NCB-07/2076/077 & KRM/SPT/NCB-08/2076/077 has been allocated by the Provincial Governmental Grant, Province No. 2, Nepal and rest of the 50% by Kanchanrup Municipality. It is informed that at least 50% of the total construction works must be completed before 30th June, 2020 (16th Asar, 2076 B.S.).
4. 5. Bidders shall submit their bids electronically and may download the bidding document for e-submission from PPMO's website <http://www.bolpatra.gov.np/eGP>, and submit their electronic bids as specified in the Instruction to Bidders. Bidders should deposit the cost of bidding document to the Reserve Account No. 1103600648432171 maintained in the name of Kanchanrup Municipality at Agricultural Development Bank, Kanchanpur Branch, Saptari and the scanned copy (PDF format) of the bank deposit voucher shall be uploaded at the time of electronic submission of the bid.
6. Pre-bid meeting will be held at Kanchanrup Municipality, Saptari at 14:00hrs on 25th Mar., 2020 (12th Chaitra, 2076 B.S.).
7. The electronic bids must be submitted through PPMO web site www.bolpatra.gov.np/eGP on or before 12.00 hours of 3rd Apr., 2020 (21st Chaitra, 2076 B.S.). Late bids will be rejected and not opened. The bids will be opened electronically at 13.00 hours on 3rd Apr., 2020 (21st Chaitra, 2076 B.S.) in the presence of the bidders authorised representatives who choose to attend at Kanchanrup Municipality, Saptari.
8. All bids shall be accompanied by a bid security, for the amount as specified in the table below, which shall be valid for minimum 30 days beyond the bid validity period. Bidders are required to submit a separate bid security for each contract for which they submit bids. The bid security/guarantee shall conform to the standard format as specified in the bid document. The bid security/guarantee issued only by the Commercial Bank or Financial Institution eligible to issue Bank Guarantee as per prevailing Law shall be accepted by the Employer. Bidders who choose to deposit the bid security amount in cash, should deposit to the Deposit/Dharauti Account No. 1103600648432102 maintained in the name of Kanchanrup Municipality at Agricultural Development Bank, Kanchanpur Branch, Saptari and the scanned copy (PDF format) of the bank deposit voucher shall be uploaded at the time of electronic submission of the bid.
9. Bidders are required to specify the total price of the bid in the latter of bid or the bid price in the bill of quantity. Failure to specify the total price of bid, in the latter of Bid or the bill of Quantities shall be ground for declaring the bid non responsive.
10. Bids shall be valid for a period of 90 days after bid opening.
11. If the last date of pre-bid meeting, purchasing and or submission falls on a government holiday, than the same time on next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
12. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
13. The Kanchanrup Municipality, Saptari reserves right to accept or reject any or all bids or annul the bidding process and reject all bids without assigning any reason, whatsoever.
